NOW COMES the Plaintiff, by and through undersigned counsel, to allege and say as follows:

PARTIES

1. Bianca Brown ("Bianca"), the Plaintiff, is a citizen and resident of Mecklenburg County, North Carolina.

2. Defendant TM Northlake Mall, LP ("Defendant Northlake Mall") is a Delaware limited partnership with its principal place of business in Connecticut. Defendant Northlake Mall owned, managed, and operated Northlake Mall in Charlotte, North Carolina where Bianca Brown was shot.

3. Defendant Spinoso Real Estate Group DLS, LLC ("Defendant Spinoso Real Estate") is a foreign limited liability company with its principal place of business in New York. Defendant Spinoso Real Estate managed and operated Defendant Northlake Mall in Charlotte, North Carolina, where Bianca Brown was shot.

4. Defendant Professional Security Consultants, Inc., ("Professional Security Consultants") is a foreign corporation with a principal place of business in California. Defendant Professional Security Consultants provided security services to Defendant Northlake Mall in Charlotte, North Carolina, where Bianca Brown was shot.

5. Defendant ARC NCCHRNC001, LLC ("Defendant Northlake Commons") is a Delaware corporation with its principal place of business in Rhode Island. Defendant Northlake Commons owned, managed, and operated Northlake Commons in Charlotte, North Carolina, where the events giving rise to this Complaint began.

6. Defendant Hiffman Asset Management, LLC d/b/a "Hiffman National" ("Defendant Hiffman National") is an Illinois corporation with its principal place of business in Illinois. Defendant Hiffman National managed and operated Defendant Northlake Commons in Charlotte, North Carolina, where the events giving rise to this Complaint began.

7. Defendant S&S Management Group, LLC d/b/a "Security Solutions of America" ("Defendant Security Solutions") is a North Carolina limited liability company. Defendant Security Solutions provided security services to Defendant Northlake Commons, where the events giving rise to this Complaint began.

8. Upon information and belief, Defendant John Doe ("Defendant John Doe") is a resident of Mecklenburg County, North Carolina. Defendant John Doe recklessly drove his vehicle through Defendant Northlake Commons' property and followed the vehicle in which Bianca rode into the Northlake Mall property, where he shot Bianca.

JURISDICTION & VENUE

9. Jurisdiction is proper pursuant to N.C. Gen. Stat. §§ 7A-240, 7A-243 and § 1-75.4.

10. Venue properly lies in Mecklenburg County pursuant to N.C. Gen. Stat. § 1-82.

11. All Defendants have been properly served and brought before this Court pursuant to Rule 4 of the North Carolina Rules of Civil Procedure.

TERMS OF ALLEGATIONS

12. All allegations set forth in each of the paragraphs in this Complaint are incorporated by reference into each of the other sections and paragraphs in this Complaint.

13. At all times pertinent, all employees of Defendants acted in their capacity as agents of their respective employers. Resultingly, their acts, practices, and omissions are imputed to their respective employers either directly or vicariously under the principles of corporate liability, the completed and accepted doctrine, apparent authority, agency, ostensible agency, and the doctrine of *respondeat superior*.

INTRODUCTION

14. Bianca Brown was 27 years old when she was viciously assaulted.

15. Bianca is a registered nurse who enjoys cooking soul food, seafood, and Italian food. She has a young son, Brandon.

16. Bianca has lived in Mallard Creek for years. In fact, she lived there before Northlake Mall was built. Once built, the Mall presented a new fun, social and family spot just 10 minutes from Bianca's home.

17. Bianca often frequented both Northlake Mall and Northlake Commons—two adjacent commercial properties housing various restaurants and retail shops.

18. While since opening its doors in 2005 the Mall has received over \$50 million in funding, through the years, the Mall has found itself plagued by a wave of violent crime that remains inadequately addressed by its owners and managers. ¹

19. On August 13, 2022, Bianca became one of the *at least* 1,309 people victimized at or within the immediate vicinity of Northlake Mall in the five years preceding her shooting.² The extent of the criminal activity plaguing Northlake Mall before the institution of the City of Charlotte Open Data Portal, ArcGIS, in 2017 is unknown.

20. Bianca suffered six gunshot wounds to her right thigh, one gunshot wound to her left thigh, one gunshot wound to her right hand, and two gunshot wounds to her right shoulder. Bianca sustained so many gunshot wounds that "[ballistic] trajectory was difficult to assess."³

21. The pain Bianca endured from the multiple gunshot wounds lasted long after the incident. Notably, while Bianca was scheduled to have the last bullet fragments removed on September 20, 2022, the bullectomy had to be rescheduled because Bianca could not tolerate the pain of the procedure. In November, Bianca had to return to her spine specialist because of "intolerable pain" from her injuries. A pain she described as aching, crushing, sharp, throbbing, and stabbing. Bianca could not stand, walk, exercise, participate in social activities, or sleep due to the pain.⁴ Succinctly, her life was reduced to her bed, without so little as the relief of sleep.

BACKGROUND INFORMATION

22. Northlake Mall is an "enclosed, super-regional center in affluent North Charlotte, offering a powerful mix of national and regional department stores (Belk, Dillard's, Macy's), national and specialty shops, dining, and an upscale AMC theater."⁵ At 1.1 million square feet, Northlake Mall is the fourth largest mall in the Charlotte region.

23. Northlake Commons is a busy 109,113 square-feet shopping center adjacent to and just 450 meters from Northlake Mall in Charlotte, North Carolina. It is an outparcel that adjoins Northlake Mall's parking lot. Like the Mall, Northlake Commons houses numerous retail shops and restaurants.

24. In the five-year period between December 31, 2016, and August 13, 2022, the Northlake Commons and Mall areas have been affected by at least 1,309 distinct incidents of criminal activity ranging from assaults, forcible rapes, robberies, and murders. All this crime was not lost on the Defendants. American Eagle's parent company, AE Outfitters Retail Co., cited "rampant violence...reminiscent of a warzone" as the reason it abruptly closed its 7,000-square-foot store after 20 years at Northlake. American Eagle is not alone, other retailers (including Apple, Dick's Sporting Goods, Michael Kors, and Buckle) also chose to close their stores, citing rampant violent and fear for the security of their employees and customers.⁶

25. In response to the violence, representatives of Northlake Mall reassured their customers and tenants: "[t]he safety of our guests, tenants and employees is our top priority. We work closely with our partners in local, state, and federal law enforcement to monitor events in the surrounding neighborhood, *teams are onsite 24/7*. *We have implemented additional measures, some of which are visible and others that are behind the scenes*."⁷

26. Notwithstanding the Mall's reassurances, crime continued to rise, and security seemed to respond, if at all, well after the fact.

27. Commercial properties were not the only voices warning about the rampant violence plaguing the Defendants' commercial properties. The Mall's and Commons' own customer reviews warn:

a. <u>Trip Advisor Reviews</u>

- "I have a nephew-in-law who works for our local police department[,] and he has told all members of the family, local and those that visit from other locations, 'not to go to Northlake Mall EVER.' This is because there have been too many crimes committed there, including shootings in the parking lot area, store shoplifting, shootings inside the mall, to name a few."
- "We used to really enjoy coming here . . . but there have already been issues with crime[.]"
- "This mall, you don't want to go to in the afternoon or weekends. I feel very unsafe in this mall."
- "[T]he parking lot is just scary at night."

b. Google Reviews

- "My utmost concern lies with the repeated occurrences of shootings that have plagued this mall. The frequency of such incidents is alarming and poses a serious threat to personal safety. The atmosphere is tainted by an unsettling presence, and the overall feeling of security is severely compromised. It is deeply disheartening to witness the deteriorating state of this once vibrant shopping center."
- "This is a beautiful mall that desperately needs more security, any type of security. I went without knowing the history of violence in the mall and felt a very eery, uneasy feeling. I guess it's developing a reputation. I love the location and stores that hopefully don't pull out. PLEASE take these shootings seriously."
- "Mall security needs to do a better job."
- "Clearly needs more security!"
- "Several shootings have occurred here so, be safe."
- "This mall is horrible! The 5 or 6 stores that drew me to the place closed their doors and left years ago. It's also been a crime scene according to local news channels several times in recent history."
- "Use to be a peaceful place to walk-around now its feels like a death trap. Need more security."

- "WHERE is SECURITY??? And it is ALWAYS like this. I can't endanger my family any more."
- "Crime is up.****** DO NOT GO THERE [...]!"
- "I no longer visit this area due to the frequent incidents of crime; shootings, etc. It's a rough crowd in the mall at night."
- "Dirty! Clearly needs more security!"
- "Nice mall but crime has driven my family away. Hopefully they can clean up their act."
- "Such a shame crime is ruining such a nice mall."
- "Very Dangerous...No Security... Check Local Crime statistics."
- "The fact that someone was shot her point blank in the mall last Christmas Eve that is the clientel the mall is selling to. I got chased down by someone in a black SUV, thinking I cut them off. WHERE is SECURITY??? And it is ALWAYS like this. I can't endanger my family any more."
- "I wouldn't go here unless your ready to meet your maker. Tighten up on security."
- "Too much violence. Inefficient security."
- "Parking lot is a nightmare. Security spends more time at the valet than anywhere[.]"
- "Found multiple bullet cases in the parking lot. They need to step their security up."
- "I just recommended not bringing small children or your family to be on the safe side."
- "This mall has started going down hill, security needs to be beefed up."
- "Dangerous place to be at night, and keep your purse close by. Security is terrible."
- "The mall seems to be slipping a bit in its security."

28. Given then data, the events that culminated in the shooting were all but unforeseeable. With the exception of John Doe, the Defendants have had years to address the

rampant criminal activity plaguing their commercial properties. For years, the Defendants have prioritized their bottom lines over the safety and security of their patrons and visitors, leaving unaddressed years upon years of violence, and allowing the Mall and Commons "to deteriorate into an atmosphere reminiscent of a warzone, replete with violent criminals, multiple shootings, [and] terrorized tenants and customers []." Tragically, unless something forces change, the Defendants' continued indifference to the criminal activity affecting their places of business will all but guarantee continued scenes of violence and tragedy in the Northlake community.⁸

FACTUAL ALLEGATIONS

29. On August 12, 2022, at approximately 09:45PM, Bianca met with some friends at the Fox & Hound at Northlake Commons. Once at Fox & Hound, the friends enjoyed their night dancing until a little past midnight when they decided to head out.

30. At about 1:00AM everyone left. Bianca and her friend decided to ride together. As they rode through the Northlake Commons area, Bianca and others noticed a reckless driver tailgating them from Northlake Commons into Northlake Mall. The friends came to a stoplight as on Perimeter Parkway—a street that divides Northlake Commons and Northlake Mall, and which is owed by Northlake Mall. It was then that the driver of the vehicle tailgating them, John Doe, drove up to the vehicle in which Bianca rode and opened fire.

31. John Doe unleashed a storm of bullets into the vehicle in which Bianca rode. The assault did not relent until Bianca laid seemingly lifeless in a pool of her own blood. Six of the bullets penetrated Bianca's legs, two penetrated her shoulder, and one her arm. One of Bianca's friends was killed. Defendant John Doe is still at large.

32. At no point did security for either Northlake Commons or Northlake Mall respond to the nearly two dozen shots fired.

33. At some time prior to August 13, 2022, Northlake Commons entered into a contract with Defendant Security Solutions to provide security services at Northlake Commons, where John Doe first began to harass and follow the car in which Bianca and her friends rode.

34. The security services provided by Defendant Security Solutions included officers, surveillance, and control of access. Defendant Security Solutions was further contracted to warn lawful occupants of known dangers in the common areas, sidewalks, and parking lot.

35. Concomitantly, at some time prior to August 13, 2022, Defendant Northlake Mall entered into a contract with Defendant Professional Security Consultants to provide security services for Northlake Mall, where John Doe openly shot Bianca and killed her friend.

36. The security services provided by Defendant Professional Security Consultants included officers, surveillance, and control of access. Defendant Professional Security Consultants was hired to provide Northlake Mall with reasonable safety and keep it free from violence. The Defendant was further contracted to warn lawful occupants of known dangers in the common areas, sidewalks, and parking lot.

37. Defendant John Doe was a trespasser in Northlake Commons and Northlake Mall: he was not permitted to be present, and he had no legitimate business or use of the premises, beyond criminal activity. Notwithstanding, both Defendant Security Solutions and Defendant Professional Security Consultants allowed John Doe to enter and remain on the premises each Defendant was contracted to secure. Not only should the Defendant security companies have been aware that Defendant John Doe was loitering their respective premises long before he followed and unleashed a vicious attack on Bianca, but through that period they should have taken *some* action to expel the trespasser or warn of his presence.

38. Similarly, neither before nor during the assault upon Bianca, did any security guard employed by either Defendant Professional Security Consultants or Defendant Security Solutions make any efforts whatsoever to intervene, call law enforcement, call an ambulance, or request assistance from others. Even after the shooting, none of the security guards or security companies contacted local authorities to report the assault or seek medical care for Bianca. Rather, local authorities and EMS were called by Bianca, the victim.

39. All Defendants, with potentially the exception of John Doe, had actual knowledge of prior incidents of violence at the Northlake Commons and Mall areas. Over 1,300 instances of criminal activity over the course of five years—including rape, robbery, shootings, and assaults — plagued the Defendants' properties. Rather than taking *any* meaningful action to increase security or make the premises safer, the Defendants chose idleness, instead parading "security" guards who

did nothing and providing no warnings to its lawful occupants of the extensive history of violence at the commercial premises.

40. The gruesome assault upon Bianca was a preventable tragedy; one which the Defendants had ample opportunity to prevent or stop. Defendant John Doe loitered on the Defendants' commercial properties, driving recklessly, tailgating, and harassing lawful visitors and at no point did the Defendant security companies intervene. As a direct and proximate result of the acts and omissions of all Defendants, Bianca endured severe emotional and physical pain and suffering, permanent injury, scarring, disfigurement and the loss of the normal use of her body. For purposes of establishing that the case belongs in Superior Court, the damages Bianca endured far exceed this Court's minimal \$25,000 jurisdictional threshold.

FIRST CLAIM FOR RELIEF

Negligence, Gross Negligence & Premises Liability

(Defendants Northlake Commons, Hiffman National, Northlake Mall, and Spinoso Real Estate)

41. Plaintiff incorporates the foregoing paragraphs of this Complaint as if fully stated herein.

42. At all times relevant, Defendants Northlake Commons, Hiffman National, Northlake Regional, and Spinoso Real Estate (in this First Claim for Relief, collectively, "the Defendants") owned, controlled, operated, and managed either Northlake or Northlake Mall (in this First Claim for Relief, collectively, "the commercial properties") in Charlotte, North Carolina where Bianca was shot.

43. As owners and managers of lands, these Defendants had the legal duties to:

- a. Discover that criminal activity by third persons was occurring and likely to endanger the safety of lawful occupants at the commercial properties;
- b. Exercise due care to reasonably prevent or control such criminal activity upon its discovery;
- c. Take reasonable steps for the safety and protection of lawful occupants;
- d. Keep the premises in a state consistent with due regard for the safety of their lawful occupants from reasonably foreseeable third-party criminal activity;
- e. Warn of known dangers at the commercial properties; and
- f. Otherwise act as reasonable prudent property owners and property managers at all times.

44. The over 1,300 criminal incidents within a mile radius of their commercial properties in the prior five years provide Defendants abundant notice of an ongoing problem. To

that end, the Defendants should reasonably have anticipated that apathy and inaction would all but guarantee, if not *encourage*, that criminal conduct on the part of third parties would continue to affect their commercial properties and endanger the lives of occupants.⁹

45. The Defendants had both ample and reasonable opportunity to prevent or control foreseeable third-party criminal activity likely to endanger the safety of their lawful occupants indeed, they had six years and 1,312 prior opportunities worth of notice. Still, the Defendants chose indifference and inadequate action.

46. Beyond the prior incidents, Defendants specifically knew or should have known of John Doe's presence on their premises prior to the shooting. Defendant John Doe loitered on the Defendants' commercial properties, driving recklessly, tailgating, and harassing lawful visitors. Notwithstanding Defendant John Doe's flagrant conduct, the Defendants failed to intervene, require him to leave, or even as much as contact law enforcement. Succinctly, the Defendants ignored a pattern and history of crime, all which compounded to culminate in Bianca's injuries.

47. The Defendants' abysmal disregard of their duties is not an isolated occurrence, but reflective of an alarming pattern of behavior as evidenced by the dizzying data of the rampant criminal activity plaguing the commercial properties. Defendants have:

- a. Failed to provide adequate security on the commercial properties;
- b. Failed to adequately assess the need for security on the commercial properties;
- c. Failed to reasonably investigate or, in the alternative, discover the history of criminal activity on the commercial properties;
- d. Failed to monitor activity that was potentially harmful to others within the commercial properties;
- e. Failed to exercise reasonable care to provide a safe environment for the lawful occupants of the commercial properties;
- f. Failed to provide proper and adequate surveillance of the commercial properties;
- g. Failed to properly train their employees and agents in recognizing and correcting dangerous conditions and risks to lawful occupants of the commercial properties;
- h. Failed to monitor the performance of their security personnel to ensure the safety of lawful occupants on the commercial properties;
- i. Failed to monitor the performance of their contractors hired to provide security on the commercial properties;

- j. Failed to hire competent security personnel to ensure the safety of the lawful occupants on the commercial properties;
- k. Failed to implement and follow security measures commensurate with the recommendations of security experts and consultants;
- 1. Failed to implement and follow security measures requested by its on-site property managers;
- m. Failed to remove delinquent, dangerous, and unauthorized persons from the commercial properties
- n. Failed to have adequate patrols on the premises so as to deter dangerous activity on the commercial properties;
- o. Failed to warn lawful occupants of the premises, including Bianca, of the risks of criminal activity on the commercial properties;
- p. Failed to follow the instructions or recommendations of law enforcement;
- q. Failed to properly budget or allocate resources so that adequate security measures could be implemented and maintained;
- r. Failed to maintain a policy, procedure, or system of investigating, reporting, and warning of criminal activity on the commercial properties;
- s. Failed to restrict access to the premises on August 13, 2022, to only those persons who were lawfully permitted on the commercial properties;
- t. Failed to maintain, inspect, secure, patrol, and manage the commercial properties;
- u. Permitted or otherwise ignored criminal activity on the commercial properties;
- v. Permitted unauthorized or dangerous persons to come onto the premises with weapons;
- w. Permitted unauthorized and dangerous persons on the premises, contrary to the standard of practice and standards of care for commercial properties;
- x. Knowingly subjected lawful occupants of the premises to an unreasonable risk of serious physical harm;
- y. Negligently maintained, inspected, secured, patrolled, and managed the commercial properties; and
- z. Other acts of negligence that may be shown at the time of trial.

48. The Defendants had knowledge, both actual and constructive, of the need to properly maintain, secure, inspect, patrol, and manage the commercial properties: (1) they knew of the widespread dangerous activity and (2) knew of the regular presence of unauthorized or dangerous individuals on their premises prior to August 13, 2022.

49. In place of exercising ordinary care to keep their premises safe and protect lawful occupants by (1) remedying the security deficiencies about which they were aware prior to August 13, 2022, and (2) providing adequate security measures on August 12-13, 2022, the Defendants chose apathy and idleness. In doing so, they breached their legal duties to the lawful occupants of

the premises, including Bianca, and they caused and allowed Bianca to endure an unrelenting, violent assault.

50. The Defendants represented to their lawful occupants that the premises were properly maintained and reasonably safe. Indeed, that the properties would be operated and maintained "in accordance with the standards of first-class shopping centers,"¹⁰ and that "teams [would be] onsite 24/7."¹¹ Far from the standards of a "first-class shopping center[]," the Defendants have permitted their commercial properties to deteriorate "into an atmosphere reminiscent of a warzone," allowing rampant violence to flourish under its "watch" and "management."

51. Had the Defendants provided adequate security measures and exercised reasonable care in preventing or controlling the blatant and foreseeable criminal activity of third parties, the physical and mental trauma that Bianca endured could have been prevented.

52. The Defendants' failures are not a one-off, but rather indicative of a broad pattern of behavior that reflects across their employees and agents. Resultingly, these Defendants are liable for the negligent supervision, hiring, training, and retention of their employees and for the entrustment of the premises to their partners, agents, and employees. In addition, the acts, practices, and omissions of the officers, employees, and agents of the Defendants are imputed to their respective employers either directly or vicariously, under the principles of corporate liability, the completed and accepted doctrine, apparent authority, agency, ostensible agency, and *respondeat superior*.

53. Each of the Defendants' tortious acts and omissions constitutes an independent act of negligence on the part of each of them, and one or more or all of the above-stated acts was a proximate cause of Bianca's injuries.

54. As a direct and proximate result of the acts and omissions of all of the Defendants, Bianca suffered severe emotional and physical pain and suffering, permanent injury, scarring, disfigurement and the loss of the normal use of her body. For purposes of establishing that the case belongs in Superior Court, her damages are far in excess of this Court's minimal \$25,000 jurisdictional threshold.

55. Further, Plaintiff is informed and believes that the Defendants participated in or condoned conduct constituting an aggravating factor under N.C. Gen. Stat. § 1D-15(a), including willful, wanton, conscious and intentional disregard of their duties as set forth in the preceding paragraphs. These Defendants manifested alarming and extreme indifference to and disregard of the rights and safety of others, an indifference which, given the alarming data, these Defendants knew or should have known was reasonably likely to result in injury to the lawful occupants of the commercial properties. The Defendants' willful, wanton, and grossly negligent conduct entitles Bianca to recover punitive damages from each of these Defendants in the maximum amount permitted by law pursuant to N.C. Gen. Stat. § 1D.

SECOND CLAIM FOR RELIEF

Negligence & Gross Negligence

(Defendant Security Solutions and Professional Security Consultants)

56. Plaintiff incorporates the foregoing paragraphs of this Complaint as if fully stated herein.

57. At all times relevant, Defendants Security Solutions and Professional Security Consultants (in this Second Claim for Relief, collectively, "the Defendants") were hired to perform security-related services at Defendant Northlake Commons and Northlake Mall (in this Second Claim for Relief, collectively, "the commercial properties"), where Bianca was shot.

58. At all times relevant, the Defendants were under both contractual and legal duties to protect lawful occupants, including Bianca, from reasonably foreseeable third-party criminal attacks.

59. As contracted-for security service providers, the Defendants were under the duties

to:

- a. Discover that criminal activity by third persons was occurring and likely to endanger the safety of the lawful occupants of the commercial properties they were contracted to secure;
- b. Exercise due care to reasonably prevent or control such criminal activity within of the commercial properties they were contracted to secure upon its discovery;
- c. Take reasonable steps for the safety and protection of the lawful occupants of the commercial properties they were contracted to secure;
- d. To keep the commercial properties they were contracted to secure in a state consistent with due regard for the safety of occupants, including Bianca, from reasonably foreseeable third-party criminal activity;

- e. To warn of known dangers at the commercial properties they were contracted to secure; and
- f. To act as a reasonably prudent security companies.

60. Indeed, the over 1,300 criminal incidents in the last five years provide abundant notice of an ongoing problem within 1.0 miles of the commercial properties the Defendants were contracted to secure. Prior incidents notwithstanding, the Defendants specifically knew or should have known of Defendant John Doe's presence on the commercial premises prior to the shooting: Defendant John Doe loitered on the commercial properties the Defendants were contracted to secure, driving recklessly, tailgating, and harassing lawful visitors. Notwithstanding Defendant John Doe's flagrant conduct, the Defendants failed to intervene, require him to leave, or even as much as contact law enforcement.

61. Given the nature of the Defendants' services, the nature of their duties, and their knowledge of prior criminal activity within or in the immediate vicinity of the commercial properties for which the Defendants provided security services, the Defendants should have reasonably foreseen that the conditions at the commercial properties exposed lawful occupants to injury due to the criminal activity of third persons.

62. Beyond reasonably foreseeing the likelihood of continued criminal activity, the Defendants had both the duty as well as ample and reasonable opportunity—indeed, over 1,300 opportunities—to discover criminal activity by third persons, and exercise due care to prevent or control foreseeable third-party criminal activity likely to endanger the safety of the lawful occupants of the commercial premises they were contracted to secure, prior to and on August 12-13, 2022.

63. The Defendants breached their duty of care by failing both to perform the contracted-for services and by failing to exercise ordinary care to protect lawful occupants, like Bianca, and keep the commercial premises safe.

64. At all times pertinent to the shooting, the Defendants, by and through their agents, and employees were negligent in:

- a. Failing to provide adequate security on the premises they were contracted to secure;
- b. Knowingly subjecting lawful occupants of the commercial properties to an unreasonable risk of serious physical harm;
- c. Failing to exercise reasonable care to provide a safe environment for the lawful occupants of the commercial properties;

- d. Failing to provide proper and adequate surveillance of the commercial properties;
- e. Permitting or otherwise ignoring criminal activity on the commercial properties;
- f. Failing to properly train its employees and agents in recognizing and correcting dangerous conditions and risks to lawful occupants at the commercial properties they were contracted to secure;
- g. Failing to monitor the performance of its security personnel to ensure the safety of the lawful occupants of the commercial properties;
- h. Failing to monitor the performance of its contractors hired to provide security on the commercial properties;
- i. Failing to hire competent security personnel to ensure the safety of the lawful occupants of the commercial properties;
- j. Failing to implement and follow security measures commensurate with the recommendations of security experts and consultants;
- k. Allowing unauthorized or dangerous persons on the premises, contrary to the standard of practice or standard of care for a commercial properties;
- 1. Failing to remove delinquent, dangerous, and unauthorized persons from the commercial properties;
- m. Failing to adequately control unauthorized or dangerous persons on the premises, including in the common areas, sidewalks and parking lot;
- n. Failing to have adequate patrols on the premises so as to deter dangerous activity on the commercial properties;
- o. Failing to warn lawful occupants of the premises, including Bianca, of the risks of criminal activity on the commercial properties;
- p. Failing to maintain a policy, procedure, or system of investigating, reporting, and warning of criminal activity on the premises;
- q. Permitting unauthorized persons to come onto the premises with weapons;
- r. Failing to restrict access to the premises on August 12-13, 2022, to only those persons who were lawfully permitted on the commercial properties; and
- s. Other acts of negligence that may be shown at the time of trial.

65. The Defendants knew or, with the exercise of due care for the safety of lawful occupants of the commercial properties they were contracted to secure, should have known that (1) their failure to secure, inspect, and patrol the premises combined with (2) the dangerous and hazardous conditions arising from criminal activity on the premises, and (3) the pattern and history of crime, would likely result in, if not encourage, serious injuries to the lawful occupants of the commercial properties they promised to secure, including Bianca.

66. The Defendants, further, had actual and constructive knowledge of the regular presence of unauthorized individuals or dangerous persons on the premises and knew or should have known that this presence created an unsafe environment.

67. Even armed with this knowledge, the Defendants permitted Defendant John Doe to roam large while openly engaging in threatening behaviors at the commercial properties the Defendants were retained to secure. In doing so, the Defendants were derelict in their duties, failing to properly secure, inspect, and patrol the commercial properties they serviced.

68. Instead, the Defendants represented to lawful occupants that the premises were properly secured and reasonably safe; had the Defendants actually exercised reasonable care in securing the commercial properties by preventing or controlling the foreseeable criminal activity of third parties, the relentless assault Bianca endured could have been prevented.

69. Moreover, Plaintiff is informed and believes that the Defendants violated their Services Agreements with the owners or operators of the subject commercial properties by allowing known trespassers, dangerous persons, armed persons, and unauthorized persons to enter the subject premises on August 12-13, 2022 and otherwise failing to reasonably patrol and protect the premises. Bianca was a third-party beneficiary of the Defendants' respective agreements to provide security on the premises.

70. The Defendants' disregard for both their contractual and legal duties indicates alarming negligence in the supervision, hiring, training, and retention of its employees and for the entrustment of the premises to its partners, agents, and employees. In addition, the acts, practices, and omissions of the officers, employees, and agents of the Defendants are imputed to it either directly or vicariously under the principles of corporate liability, the completed and accepted doctrine, apparent authority, agency, ostensible agency, and *respondeat superior*.

71. Each of the Defendants' tortious acts and omissions constitute an independent act of negligence. As a direct and proximate result of the acts and omissions of the Defendants, Bianca suffered severe emotional and physical pain and suffering, permanent injury, scarring, disfigurement and the loss of the normal use of her body. For purposes of establishing that the case belongs in Superior Court, her damages are far in excess of this Court's minimal \$25,000 jurisdictional threshold.

72. Further, Plaintiff is informed and believes that the Defendants participated in or condoned conduct constituting an aggravating factor under N.C. Gen. Stat. § 1D-15(a), including

willful, wanton, conscious and intentional disregard of their duties as set forth in the preceding paragraphs. These Defendants manifested alarming and extreme indifference to and disregard of the rights and safety of others, an indifference which, given the alarming data, these Defendants knew or should have known was reasonably likely to result in injury to the lawful occupants of their commercial properties. The Defendants' willful, wanton, and grossly negligent conduct entitles Bianca to recover punitive damages from each of these Defendants in the maximum amount permitted by law pursuant to N.C. Gen. Stat. § 1D.

THIRD CLAIM FOR RELIEF

Assault & Battery

(Defendant John Doe)

73. Plaintiff incorporates the foregoing paragraphs of this Complaint as if fully stated herein.

74. Defendant John Doe brutally and intentionally attacked Bianca.

75. In brandishing his firearm, aiming, and shooting at Bianca, Defendant John Doe created a reasonable apprehension of great and imminent bodily harm and injury on the part of his victim, Bianca.

76. Defendant John Doe committed a battery upon Bianca in the following ways:

- a. Intentionally causing bodily contact with Bianca;
- b. Causing physical pain or injury through such bodily contact; and,

c. Causing such bodily contact without Bianca's consent.

77. Bianca's injuries were a direct and proximate result of the assault and battery by Defendant John Doe. But for the assault and battery, Bianca would not have sustained over eight gunshot wounds to her body.

78. As a direct and proximate result of Defendant John Doe's assault and battery, Bianca suffered severe emotional and physical pain and suffering, permanent injury, scarring, disfigurement and the loss of the normal use of her body. For purposes of establishing that the case belongs in Superior Court, her damages are far in excess of this Court's minimal \$25,000 jurisdictional threshold.

79. The actions of Defendant John Doe were committed with malice and exhibited willful and wanton conduct manifesting a conscious and intentional disregard for the rights and safety of Bianca, and thus Plaintiff is entitled to punitive damages pursuant to N.C. Gen. Stat. § 1D.

WHEREFORE, Plaintiff prays of the Court as follows:

- 1. That the Plaintiff have and recover of all of the Defendants, jointly and severally, all categories of damages;
- 2. That the Plaintiff recover punitive damages from each of the Defendants;
- 3. For a jury trial on all issues so triable;
- 4. For pre and post judgment interest;
- 5. That the costs of this action be taxed against Defendants; and
- 6. For such other and further relief as the Court may deem just and proper.
